DIRECTIONS FOR USE: For slime control in pulp, paper and paperboard mills, use 150 to 700 g per 1,000 kg of dry furnish. This product is not to be used in the production of paper or paperboard that comes into contact with food.

For control of bacteria and fungal slime in industrial recirculating cooling water systems, add 20-60 mg/L once a week based on system's volume. If contamination is excessive, use 80-120 mg/L until the system cleans up. Feed directly into the cooling system's water where it will be uniformly mixed. Do not apply to potable water supply. Do not use PVC or carbon steel feeding equipment.

PRECAUTIONS: This chemical is irritating to the skin and eyes. Avoid contact with skin, eyes, or clothing. Wear goggles or face shield and rubber gloves. Keep container closed when not in use. Do not spills or use near heat or flame. Remove and wash contaminated clothing before reuse.
