DIRECTIONS FOR USE:

Kills over-wintering Red Mite, Leafroller, Pear Psylla, Scale and Currant Aphid. May be applied to fruit trees, ornamental trees and shrubs. Do not use on Beech, Butternut, Colorado Blue Spruce, Douglas Fir, Hickory, Holly, Sugar Maple, Japanese Maple, Walnut and Delicious variety of apple.

RATE: Mix 60 mL (4 tablespoonfuls) in 3 litres of water and mix thoroughly. Shake frequently while using. Prepare fresh spray emulsion before each use. Do not store diluted spray.

COMBINATION DORMANT SPRAY: Fruit trees, roses and deciduous ornamentals. For over-wintering insects (eggs), oyster shell scale, San Jose scale, rose scale, black scale as well as over-wintering fungus disease. Mix 120 mL (8 tablespoonfuls) of White Rose Guardian Liquid Lime Sulphur plus 60 mL (4 tablespoonfuls) of White Rose Guardian Dormant Oil Spray in 3 litres of water.

TIMING: Apply in early spring when danger of frost is past, before leaf buds show green at tips. Wet all parts of trees

thoroughly but do not overspray. Spray on a mild morning to allow mixture to dry quickly. Do not spray during freezing weather.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Avoid inhalation of spray mist. Wash hands after use.

FIRST AID: This product contains petroleum distillates. If swallowed, DO NOT induce vomiting. Use gastric lavages and saline cathartics. If patient is unconscious, give him air. Call a poison control centre. Move patient to hospital or doctor's office immediately.

DISPOSAL: Dispose of empty container with regular garbage. Do not reuse.
