DIRECTIONS FOR USE: For use only for formulating purposes. Subsequent formulators are responsible for providing documentation to support the Pest Control Products Act. To be used only in the manufacture of a product which is registered under the Pest Control Products Act. Read Technical Bulletin for formulation details.

PRECAUTIONS: Harmful in contact with skin and if swallowed. Irritating to skin and eyes. Wear protective gloves when handling. Remove any contaminated clothing immediately. Wash hands thoroughly after handling. Avoid breathing dust.

FIRST AID INSTRUCTIONS: IF SWALLOWED, GET MEDICAL ATTENTION IMMEDIATELY. If victim is conscious, wash out mouth and give plenty of water to drink. If medical aid is not readily available, induce vomiting by touching the back of the throat with a finger or blunt object. The skin is an important route of absorption. If on skin, contaminated clothing should be removed as soon as possible and skin washed with soap and water. In case of eye contact, flush eyes immediately with water for at least 15 minutes. Get medical attention. In case of inhalation, stop handling product and move away from dusty environment and seek medical attention immediately. If victim's breathing stops, begin artificial respiration.

TOXICOLOGICAL INFORMATION: Lindane is an organochlorine pesticide. Symptoms of poisoning are associated with effects on the central nervous system. Following acute overdose: Initial excitement and apprehension, initial respiration accelerated followed by respiratory depression, muscular tremor followed by convulsions. Treatment is aimed at controlling convulsions, using diazepam given intravenously for preference.

DISPOSAL: Canadian formulators of this technical should dispose of unwanted active and containers in accordance with municipal or provincial regulations. For additional details and clean up of spills contact the regional office of Conservation and Protection, Environment Canada.

SPILLAGE CLEAN-UP: Keep bystanders away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (respirator and coveralls), sweep up all product and shovel into a drum. Add broken packages to the drum and seal for removal to an approved disposal site. Formulators of this technical should dispose of unwanted active containers in accordance with municipal or provincial regulations. For additional details and clean up of spills contact the regional office of Conservation and Protection, Environment Canada.

Wash with water and mop up into a drum for disposal to an approved disposal site. Remove and wash all protective clothing and equipment. Shower with soap and water on completion of mopping-up operation.
