RATS: Break and apply 1 to 4 sticks of Maheu&Maheu Rodent Cake (usually at intervals of 5 - 10 m) per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

MICE: Break each 114 g stick of Maheu&Maheu Rodent Cake into four 28 g pieces. Place one 28 g piece of Maheu&Maheu Rodent Cake at 2.5 - 4 m intervals. Two 28 g pieces may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

RATS/MICE: Replace contaminated or spoiled bait immediately. Collect and dispose of unconsumed bait and dead exposed animals according to DISPOSAL paragraph. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

DIRECTIONS FOR USE: Use bait to control the Norway rat (*Rattus norvegicus*), Roof rat (*Rattus rattus*), and House mouse (*Mus musculus*) in and around dwellings, farm buildings, food service establishments (non-food areas), granary bins (empty), processing plants (feed, food, non-food areas) and storage areas (non-food).

SELECTION OF TREATMENT AREAS: Determine areas where rats and/or mice most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.
