DIRECTIONS:

FLY KILLER aerosol insecticide is especially designed for electrically operated automatic aerosol dispensers. Use SANEX FLY KILLER in and around restaurants, hospitals, dairies, food processing plants, meat packing plants, homes, kitchens, and dining rooms. One unit for each 170 cu. meters of space to be treated is recommended. Place 2.5 to 3 meters above the floor. A specific amount of concentrate insecticide is automatically released every 15 minutes through the periodic activation of the metered valve. Effectiveness of SANEX FLY KILLER will be noticed within one hour after the electric dispenser has been activated in killing a proportion of the flies, gnats or mosquitoes present. This 340 g can of SANEX FLY KILLER contains approximately 3300 "shots" and will operate at 15 minute intervals for 34 days on a continuous 24 hour basis. Container

should be replaced once a month.

PRECAUTIONS:

Keep out of reach of children. Do not puncture, incinerate or expose to heat, even when empty. In kitchens, dining rooms, dairies, and other food handling establishments, food should be covered while dispensing. Do not use in nurseries or rooms where infants, ill, or aged people are confined. Cover fish bowls in treated areas. In meat packing and food processing plants spray only when plant is not in operation. Remove exposed meat products, ingredients, or packaging materials before spraying. Wash and rinse thoroughly with potable water all surfaces that may contact meat food products or other food products, after spraying and before re-use for food processing. Contents under pressure.
