DIRECTIONS FOR USE:

DANTOGARD® PLUS LIQUID preserves and aids in the control of the growth of bacteria and fungi which can cause odour and breakdown of appearance and physical properties in liquid detergents, soft soaps, and other water-based detergents such as floor cleaners, car wash detergents and fabric softeners. Add DANTOGARD® PLUS LIQUID to the formulation to be preserved at a rate of 0.2 to 2.5 kg per 1000 kg or 200 to 2,500 ppm based upon the total weight of the product to be preserved. DANTOGARD® PLUS LIQUID can be added to the batch process after all heating steps are completed and the formulation temperature is below 37°C.

PRECAUTIONS :

KEEP OUT OF REACH OF CHILDREN. HARMFUL IF INHALED. Do not get in eyes, on skin or on clothing. Avoid breathing dust. Wear long-sleeve shirt, long pants, and chemical-resistant gloves when handling the concentrate. If there is potential to generate mist during handling, wear mist filtering respiratory protection. Formaldehyde can be released during use of this product. It is recommended that this product not be used in circumstances, which would result in formaldehyde air concentrations in the workplace exceeding the exposure levels established by occupational health and safety authorities in your jurisdiction. If values exceed this level, it is recommended that NIOSH approved respiratory protection be worn. This product is toxic to fish and aquatic invertebrates. Do not discharge into lakes, streams, rivers or ponds.

FIRST - AID :

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
