APPLICATION INFORMATION:

FOR DOGS AND CATS:

1. Start by spraying your pets head, (avoiding contact with the eyes and mouth) and work your way back to the hind quarters. Spray under the haircoat by backcombing against the haircoat with your hand or brush. Wet, but do not soak, the entire haircoat and exposed skin thoroughly to ensure adequate

coverage. The microcapsules in 3M Pet and Premises Flea Spray adhere to the haircoat and continuously release their active ingredients to provide at least 30 days residual activity.

2. If required, reapply 3M Pet & Premises Flea Spray Weekly.

NOTE: Do not apply to nursing females or puppies and kittens under 8 weeks of age. Do not use on sick animals. Do not use on animals under drug or pesticide treatment. For use on pregnant animals consult a veterinarian.

FOR PREMISES:

1. Thoroughly clean and vacuum your home. Seal vacuum bag and dispose in garbage.
2. Spray 3M Pet & Premises Flea Spray on any area that may be harbouring fleas. This usually include pet resting areas, furniture, under beds, hallways, closets, etc. Flooring particularly carpets, should be sprayed thoroughly.

NOTE: WE RECOMMEND PATCH TESTING CARPETS AND FURNITURE ON A HIDDEN AREA, AND ALLOW THESE AREAS TO DRY BEFORE APPLICATION.

3. We recommend you limit vacuuming to high traffic areas for 30 days. 3M Pet & Premises Flea Spray provides residual activity against fleas for at least 30 days when applied according to instructions.
4. Repeat application as needed.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes. Avoid breathing stray mist. Keep container closed when not in use. Cover or remove fish bowls and aquaria. Do not contaminate food utensils, feed or water. Wash hands after spraying and before eating or smoking. Do not use in nurseries or rooms where infants, ill or aged persons are confined. This product may pose a hazard to pollinating insects.
