DIRECTIONS FOR USE: Apply a light spray on all exposed skin except face. To apply to face, spray on hands, then spread on face avoiding eyes and mouth. Wash or wipe palms after applying. For ticks and chiggers, apply to shoe tops, socks, and openings in clothing, except on synthetic fabrics such as rayon, acetate, and dynel. FOR EXTENDED EXPOSURE: Allow one "repellent free" day for every 4 to 7 days of continuous use. Wash all exposed skin daily with soap and water.

DANGER - EYE IRRITANT. Do not apply to KEEP OUT OF REACH OF CHILDREN. DO NOT USE ON INFANTS OR TODDLERS. sunburned, damaged or irritated skin. Harmful if swallowed.
