#### **DIRECTIONS**

For best results, apply a thin, uniform coating on both sides of the foliage when insects appear. Dust when air is calm. Repeat as needed right up to one day before harvest time for all crops. 500 g will cover 130 metres of row.

Use on all vegetables including Potatoes, Beets, Tomatoes, Rhubarb, Cabbages, Cauliflower, Broccoli, Turnips and Radishes. Effective against **Aphids, Potato Beetles, Leafhoppers, Cabbage worms, Corn borers and Beetles.**

It kills both chewing and sucking insects on vegetables, vine crops and flowers but leaves no residue which is poisonous or dangerous to humans or warm blooded animals if crops are harvested one day after treatment. Garden Insect Dust may be applied from the shaker-top package or may be used in other types of dusters.
