DIRECTIONS FOR USE

Mr. SWAT is a ready-to-use solution for mosquito and black fly  
control. For most effective treatment apply as a dense fog close

to the ground, around shrubs, lawns, and exterior surfaces of screens, doors, window frames, foundations and other places where insects enter. Apply at a rate of 150-200 mL of Mr. SWAT per 1,000 square meters. Fog in the direction of a breeze while moving away allowing the fog to drift into infested areas, contacting as many insects as possible. Repeat treatment as necessary.

#### PRECAUTIONS

Operator must wear mask and protective clothing. May be harmful if swallowed, inhaled or absorbed through the skin. Do not contaminate any body of water. Toxic to wildlife. Keep out of reach of children. Store tightly closed in original container. Wash after handling or use. Keep product away from any source of heat. Do not fog into or near open flames.

#### FIRST AID

For skin contact, wash with soap and water. If in eyes, flush with plenty of water, call a physician. Contains petroleum distillates, do not induce vomiting if swallowed.

#### TOXICOLOGY

Atropine sulfate is antidotal. Do not give morphine. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.
