DIRECTIONS FOR USE

Apply with a stiff brush, spatula, or putty knife 10 cm above to 30 cm below ground level. Wood must be debarked prior to application. Waterproof bandage such as a piece of garbage bag or tar paper may be wrapped around the treated area, and nailed or stapled, to prevent the loss of the preservative into the ground. Wrapping is not entirely necessary, if allowed to dry for one week. It may also be applied by spreading the paste preservative on a waterproof bandage, and then wrapped around the area to be treated.
