PYRA-FOG 100 is non toxic to human beings or pets and will not stain when used as directed. PYRA-FOG 100 is formulated to control cockroaches, silverfish, weevils infesting stored food products, bed bugs, flies, and certain other insects in their accessible

stages. PYRA-FOG 100 is relatively safe for use around foodstuffs when used as directed. For best results, PYRA-FOG 100 should be used with electric sprayers, but hand or compressed air sprayers may be used.

DIRECTIONS

FOR USE IN FOOD PROCESSING PLANTS: In meat and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after application and before re-use for food processing.

WEEVILS & MOTHS INFESTING STORED FOOD PRODUCTS: Clean areas to be sprayed, especially cracks, crevices and around machinery. Good housekeeping makes for more effective insect control and a definite savings in the amount of CHEMSEARCH PYRA-FOG 100 required. To spray food storage ares, remove food products from shelves and racks. Spray these areas thoroughly with PYRA-FOG 100 and replace food products. For packaged food, spray in such a manner that a light mist will fall upon the packages. For food products in sacks, spray thoroughly between and around the sacks paying particular attention to all cracks, cervices, walls, and any other places that might offer shelter to the weevils. Contact as many weevils as possible. After all the local areas of storage have been sprayed, close all windows and doors.

Thoroughly fog the entire storage areas being extremely careful that all open food products are covered. Do not allow the spray to contact open food products. After 10 to 20 minutes, sweep up and destroy the fallen insects. Repeat spraying at least once a week or when reinfestation becomes evident.

FOR COCKROACHES, SILVERFISH AND CERTAIN OTHER CRAWLING INSECTS: Direct spray in such a manner as to penetrate all cracks, crevices, and other hiding places. Thoroughly fog around shelves, under sinks, refrigeration equipment, dishwashing machines, and bottle washers. Treat all returned bottle cartons and cases. Contact as many insects as possible. For routine control, spray PYRA-FOG 100 at least once a week. For badly infested areas, spray daily. During the summer months, spraying twice a week is advisable.

FOR BED BUGS: Spray mattress, bedstead, corners, etc., wherever

insects might be, as well as the holes or cracks and other hiding places around the bedroom, around baseboards, walls, and floors. Spray should be directed into all cracks and hiding places about the room. Spraying should be repeated at regular intervals or whenever these insects are in evidence.

FOR FLIES AND MOSQUITOES: Close all doors and windows before spraying. Direct spray towards the ceiling and continue spraying with PYRA-FOG 100 until the area is thoroughly fogged. After 10 to 20 minutes, sweep up and destroy all fallen insects. Repeat spraying as often as necessary.

PRECAUTIONS IN USE: Avoid breathing of spray mist and ventilate sprayed areas after application. Avoid contamination of food, utensils and food preparation areas. Combustible mixture. Do not apply near open flame.
