DIRECTIONS: Space spray application should be carried out at
weekly intervals depending upon the rate of infestation. Apply
Bugcon Super at a rate of 100-400 mL per 100 m³ with a machine
that produces an aerosol mist. Ventilate the building before
re-occupancy. As a surface spray, apply at an even rate of 2-3 L
per 100 m². Spray must contact insects to control.

PRECAUTION: Product contain petroleum distillates. Do not store
or use near fire or flame. Wear mask or respirator and

protective clothing when applying spray mist. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, food, or water. In food processing, meat packing and food service establishments, apply only when plant is not in operation. Remove all food and packing materials before treatment. Cover all food processing services and thoroughly clean with potable water before re-use. Do not use in milk processing plants or milk parlours. Keep out of reach of children. Do not use near birds, fish or pets. Do not spray on plastic or varnished surfaces. Do not spray closer than one meter to fabric. Do not use on tiled floor surfaces or rubber backed rugs.
