Spray ant trails and hills. Repeat as necessary. For carpet beetles; treat underside of carpets, floors, baseboards, cracks, crevices, closets, and infested areas of shelving. Repeat treatment as necessary. DO NOT USE ON RUBBER-BACKED CARPETS.
