COOLING WATER SYSTEMS:

For control of bacterial and fungal slime in commercial and industrial cooling water systems add Formula 3455 as follows:
Initial dose: 40 to 50 mL per 1000 L of water in the system.
Maintenance dose: every 2 to 5 days or as needed 5 to 25 mL per 1000 L of water in the system.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN Harmful if swallowed. Workmen handling the product should wear rubber gloves and goggles and should avoid contact of the product with clothing or skin. Avoid contact with skin and eyes. Causes eye damage and skin irritation. Keep the drum closed when not in use. Do not reuse container. Destroy when empty.

FIRST AID: After exposure, wash promptly and thoroughly with an abrasive soap and cool water and finally glycerine. If swallowed, call a physician immediately. Give patient doses of egg whites, milk or water. Then induce vomiting. In case of persistent irritation of the skin, obtain medical attention. If the product gets into the eyes, flood eyes immediately and thoroughly with cool water for 15 - 30 minutes. See a physician if any irritation persists.
