DIRECTIONS:

PRO-3 CONCENTRATE INSECTICIDE is recommended for use in homes, restaurants, food processing plants, warehouses, and industrial installations, to control cockroaches, granary insects, granary weevil, rice weevil, confused flour beetles, red flour beetles, meal moths, cadelles, grain mites, saw-toothed grain beetles, flies, mosquitoes, small flying moths and gnats.

ULV APPLICATORS: Remove or cover exposed food and food handling surfaces. Close room and shut off all air conditioning or ventilating equipment. Apply at the rate of 100 mL of PRO-3 per 100 cubic meters of space. Leave room closed for one half hour. Ventilate room thoroughly before re-entry. Decrease application rate for larger areas to as little as 100 mL per 100 cubic

meters.

ORDINARY MECHANICAL FOGGING EQUIPMENT: PRO-3 can be used diluted in equipment such as a microsol, Fogmaster or atomist. Remove or cover food and food handling surfaces. Close room and shut off all air conditioning or ventilating equipment. Dilute PRO-3 with base oil at the rate of 1 part concentrate plus 29 parts of oil and mix well. Apply at the rate of 200 mL diluted spray per 100 cubic meters of space. Direct fog upward towards upper corners of room and ceiling area. Leave room closed for one half hour. Ventilate room thoroughly before re-entry.

USE AS A CONTACT SPRAY: Dilute PRO-3 with base oil at the rate of 1 part concentrate plus 29 parts of oil and mix well. Apply with a sprayer that gives large, spray particles. Spray outside walls of grain bins, flooring, about base of milling machinery, walls and baseboards, areas behind cabinets, around pipes and other insect harbourages using 5 L of sprayer per 100 square meters of surface. Force spray into all cracks and crevices. Repeat applications as necessary.

PRECAUTIONS:

KEEP AWAY FROM CHILDREN AND PETS.

Product contains Petroleum Distillate. Do not store, pour or use near open flame. Harmful if swallowed. All food processing surfaces should be covered during treatment or thoroughly cleaned before use. Avoid breathing spray mist. Wear a mask or respirator when fogging or misting. Remove pets, birds and cover fish aquariums before spraying. Keep container closed and store in a cool place.

"In meat and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after application and before re-use for food processing."

FIRST-AID:

For skin contact, wash with soap and water. If in eyes, flush with plenty of water.

DANGER: this product contains petroleum distillates. Do not ingest. If ingested do not induce vomiting. If patient is unconscious give hum air. Obtain medical attention immediately.

TOXICOLOGY:

Treatment for the various reactions is symptomatic.

DISPOSAL AND DECONTAMINATION:

Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environmental Protection, Environment Canada.
