DIRECTIONS FOR USE:

Anti-Microbial agent for the control of fungi, bacteria and roots in sewer lines.

APPLICATION AND RATES:

Use hydraulic type spray equipment to produce fine pressure of 70 to 126 g/mm². Two hollow cone type nozzles should be mounted on a carriage that will maintain nozzle position near the centre of pipe being sprayed. One hollow cone spray should be directed forward, the other to the rear in a manner to contact all pipe surfaces at angle of 60' to 80'.

The spray must have good hydraulic impact and strike the pipe and roots from all sides. Apply 1.0 to 2.0 litres of product to each 10 metres of sewer line, 15 to 30 cm in diameter. Add 3 parts of water to one part of Metam Fluid 325 g/L.

RESTRICTIONS AND LIMITATIONS:

1. Use immediately after mixing with water. Do not allow the solution to stand.
2. Apply product only as specified on this label.
3. Do not apply by air.

PRECAUTIONS:

1. **KEEP OUT OF REACH OF CHILDREN.**
2. Stay out of treated area.
3. Avoid contact with skin, eyes and clothing. Avoid inhalation of spray mist.
4. Wash thoroughly after handling and before eating, drinking or smoking.
5. Do not wear leather shoes when applying the product unless they are protected from Metam Fluid 325 g/L.
6. This product is toxic to fish.
7. Avoid contamination of food, feed, ponds, lakes, ditches, domestic or irrigation water.
8. Keep off desirable lawns, plants or crops.

FIRST AID:

IN CASE OF EYE CONTACT: Flush with clean water for at least fifteen minutes and consult a physician.

IN CASE OF SKIN CONTACT: Remove contaminated clothing. Wash skin thoroughly with soap and water immediately.

IF SWALLOWED: **Induce vomiting.** Give activated (medicinal) charcoal. Avoid giving reabsorption stimulating substances like fats (milk, castor oil) or alcohol.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

STORAGE:

1. Store in a cool, dry, ventilated area away from feed.
2. Keep away from heat, fire and sparks.
3. Store in tightly closed original container. Do not store below 0°C.

DISPOSAL:

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site.

Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency.
