DIRECTIONS FOR USE

Cutting Fluids:

To inhibit the growth of bacteria and fungi, add 300 to 3,000 ppm based on the total weight of the diluted fluid.

PRECAUTION

KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Avoid contact with eyes, skin, clothing and the contamination of food. Wear safety glasses (goggles), rubber gloves and body-protective clothing. Refer to the Material Safety Data Sheet.

FIRST AID

Eye exposure: Flush with clean, cool water for at least 15 minutes or longer till irritation subsides. See a physician if irritation occurs. Skin exposure: Wash with a mild soap and water. See a physician if irritation occurs. Remove and wash contaminated clothing (including shoes) before reuse.

Inhalation: Use proper respiratory protection to immediately remove the affected person from exposure. Administer artificial respiration if breathing has stopped. Keep at rest. Get prompt medical attention. Ingestion: DO NOT INDUCE VOMITING. Rinse mouth with copious amounts of water or milk, first. Irrigate the oesophagus and dilute stomach contents by slowly giving one (1) or two (2) glasses of water or milk. Avoid giving alcohol or alcohol related products. In cases where the individual is semi-comatose, comatose or convulsing, DO NOT GIVE FLUIDS BY MOUTH. In all cases, seek immediately medical assistance.
