SHAKE WELL BEFORE USING. Aim spray away from people.

INDOORS-FLYING INSECTS (MOSQUITOS HOUSEFLIES GNATS): Direct  
spray mist to all parts of room. Leave treated area. Keep room  
closed for 15 minutes. Ventilate area.

FOR CRAWLING INSECTS: Ants, spiders, cockroaches, earwigs,  
sowbugs. Spray into hiding places, cracks, crevices, moist

areas, openings around pipes and sinks, under refrigerators, baseboards, and storage areas. Spray directly on insects where possible.

OUTDOORS-FLING INSECTS: Spray areas infested with mosquitos, wasps, gnats, houseflies, and flying moths. Hold container 45-60 cm from shrubs, bushes and grass. Spray with slow sweeping motion 1-3 seconds per cubic metre of space, moving away from treated areas. When spraying open porches and patios, allow spray to dissipate before occupying treated areas.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Cover or remove all foods before spraying. Do not contaminate feed or foodstuffs. Remove pets, birds, and cover fish aquariums before spraying. Do not use on edible crops.

FIRST AID: If product get on skin, wash thoroughly with soap and water. If product gets in eyes, flush with water. If irritation develops, seek medical attention.

DISPOSAL: When container is empty, press valve to release all remaining pressure. Wrap and discard empty container in household garbage.
