DIRECTIONS FOR USE

For the control of GRASSHOPPERS on pastures, roadsides, forages, cereal crops and waste areas.

For ground or aerial broadcast application.

For moderate infestations of young grasshoppers: 2.0 kg of bait per hectare.

For Severe Infestations of young grasshoppers: and moderate or

severe infestations of adult grasshoppers, or all instances where the crop canopy is thick: 3.0 kg of bait per hectare. (2.75 lb of bait per acre)

The bait should be broadcast in a manner that will spread the required amount evenly over the area to be treated.

REPEAT APPLICATIONS ONLY AS NECESSARY BUT NOT MORE FREQUENTLY THAN ONCE A WEEK DURING PERIOD OF HEAVY INFESTATION AND ONCE EVERY TWO WEEKS DURING MODERATE TO LOW INFESTATIONS.
