DIRECTIONS FOR USE: Calmic Type P Formulation – Standard is for use only in either the fully automated electronic or hydraulic Calmic systems and is intended as a surface sanitizer for urinals. The Calmic System will automatically dose approximately 0.2ml of product in to the last 100ml of the flush. Using the Calmic key, unlock the outer casing of the Calmic system and fill reservoir inside with product as supplied. Once reservoir is full, ensure the outer casing is locked shut with the Calmic key.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. HARMFUL IF SWALLOWED OR INHALED. DO NOT SWALLOW. DO NOT INHALE AEROSOLS OR VAPOURS. CORROSIVE TO EYES OR SKIN. DO NOT GET IN EYES, ON SKIN OR CLOTHING. AVOID CONTAMINATION OF FOOD. WEAR LONG SLEEVE SHIRT, LONG PANTS, CHEMICAL RESISTANT GLOVES AND GOGGLES WHEN HANDLING THE PRODUCT.

FIRST AID: If splashed in eyes or on skin, flush thoroughly with water for 15 minutes. For eye contact, get medical attention IMMEDIATELY. If on clothes, remove clothes immediately. If breathed in, move person to fresh air. If swallowed, drink two or three glasses of milk or water. Do not induce vomiting. Call a physician or the Poison Control Centre IMMEDIATELY. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be needed.
