When the multi-cycle programmer switch is set to position 3 'NORMAL' the automatic dispenser will release a metered dose of 55 mg of APAMIST insecticide each 15 minutes. The continuous use of APAMIST insecticide will reduce the flying insect populations - the effect should be noticeable within a few hours. Each can contains enough product to protect a room of 170 cu. m of free flow air space for up to 60 days.

USE AREA: Restaurants, food plants, dairies, meat packing plants, stables, cow barns, poultry houses, ski lodges and other areas with at least 170 cu. m of free flow air space where flies, mosquitoes and gnats are and annoyance.

DIRECTIONS: Remove protective cap from top of APAMIST can and affix can to DYNAMISTER special automatic dispenser. place the DYNAMISTER 2-3 metres above the floor at a point where air flow will carry insecticide throughout the area. Do not install directly over food or food packaging surfaces.

PRECAUTIONS: In Meat packing plants, spray only when plant is not in operation. No exposed meat products, ingredients or packing materials may be left in the room. Cover food handling equipment. Any treated surface that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for meat processing.
