DIRECTIONS FOR USE:

Biosperse 201 provides excellent control over bacterial and fungal slime formation in cooling towers and similar recirculating cooling water systems. It should be added directly to the water in the sump at a dosage of 60-120 parts per million.

Treatment is usually required once to three times per week or as needed. More detailed dosage and application information is provided in the data sheet describing this product.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful or fatal if swallowed. May cause skin or eye irritation. Wash thoroughly after handling. Do not use for potable water systems or where contamination of potable water may occur. This product is toxic to fish. Do not add to lakes, streams or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes.

FIRST AID INSTRUCTIONS:
