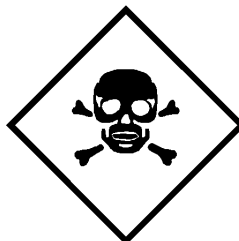

FIRST AID

Do not breathe spray mist. Keep product away from fire, open flame, lighted electric bulbs and other sources of heat. Do not allow water to be introduced to contents of this container. Harmful if swallowed. Causes severe eye irritation. May cause skin irritation. Do not get on skin or in eyes. Wear long-sleeved shirt and long pants, chemically resistant gloves and eye protection when handling this product. Harmful to fish. Do not contaminate bodies of water or ditches with contents or used container.

STORAGE

Store in original container away from food, feed and seed and all sources of heat. Keep container closed. Do not allow water to be introduced to the contents of this container. This product is not affected by freezing.

SPILL CLEANUP

1. Spread a suitable absorbent such as clay or other absorbent on the liquid.
2. Place sweepings in an open drum.
3. Generously cover the contaminated area with a common household detergent. Using a stiff brush, work the detergent into the spill material using sufficient water to form a slurry. Brush the slurry into cracks and crevices, and allow to stand for 2 to 3 minutes.
4. Spread a suitable absorbent such as clay or other absorbent on the slurried liquid, and shovel the absorbed material into an open drum.
5. Repeat if necessary.
6. Flush area with water, while observing proper environmental precautions.
7. Seal drum and dispose of contaminated material in accordance with municipal or provincial recommendations. See DISPOSAL section.

DECONTAMINATION AND DISPOSAL

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean up of spills.

CONTAINER DISPOSAL:

FOR DISPOSAL OF PLASTIC JUGS:

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

FOR REFILLABLE CONTAINERS:

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not use this container for any other purpose.

If the container is not being refilled, refer to the section "FOR DISPOSAL OF PLASTIC JUGS".

PRODUCT INFORMATION

RELY adjuvant is a cationic surfactant for use with TOUCHDOWN XP, TOUCHDOWN 480 and ROUNDUP Herbicides.

DIRECTIONS FOR USE

TOUCHDOWN XP: When used with TOUCHDOWN XP for annual weed and quackgrass (short term) control add RELY Adjuvant to the spray solution at a rate of 0.5% v/v (0.5 litres RELY per 100 litres spray mixture). Failure to add adjuvant or applying the incorrect rate will result in unacceptable weed control. Refer to the TOUCHDOWN XP label for use rates, mixing and spraying directions, application timings and other use directions.

TOUCHDOWN 480 and ROUNDUP: RELY Adjuvant may be tank mixed with TOUCHDOWN 480 and ROUNDUP for improved annual weed control and short term quackgrass control as described on the respective herbicide labels. Add RELY Adjuvant to the spray solution at a rate of 0.5% v/v (0.5 litres RELY per 100 litres spray mixture). For further information on when to include adjuvant in mixture with TOUCHDOWN 480 and ROUNDUP, use rates, mixing and spraying direction, application timings and other use directions, refer to the appropriate herbicide label.
