Effective against ants, cockroaches, silverfish, spiders, earwigs, sowbugs, crickets, certain beetles, boxelder bugs, fleas, bed bugs, chewing and sucking insects such as leaf hoppers, exposed thrips and certain aphids in gardens and houses.

DIRECTIONS FOR HOUSES:

Lightly coat the areas where the insects crawl and hide such as cracks and crevices, underneath built-ins, around pipes and drains, in storage cabinets, behind medicine cabinets, in electrical outlet boxes, garbage cans and in attics and

basements. Repeat as necessary, probably once a month. Contact insects directly with the dust when possible.

Bed Bugs: Dust thoroughly both sides of the mattresses and beds.

Fleas: Thoroughly dust sleeping quarters of pets and floors. Do not treat pets with this product. For effective flea control, pets should be treated with a registered flea control product designed for use on pets (N.B. this product is not for use on pets), and treatment of the pet must be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas prior to treatment with this product.

DIRECTION FOR GARDENS:
(Ornamental and flower gardens)

Lightly apply the insecticide dust when plants are dew covered or previously moistened with a spray of water. Coat both upper and lower surfaces of leaves. Repeat weekly. For the protection of bees early or late dusting hours (while blossoms are closed) are recommended. For best results, apply in evening or cloudy day when air is still. Do not apply in direct sunlight or when temperature exceeds 32°C. Contact insects directly with the dust.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN

Cover or remove food stuffs, utensils and aquariums from room being dusted. Avoid inhalation, as product contains Diatomaceous Earth (silicone dioxide), a very fine powder. Use with adequate ventilation. Do not use as a general space spray.

FIRST AID:

If on skin, wash thoroughly with soap and water. If in eyes, flush with clean water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention at once.

DISPOSAL:

Do not reuse empty container. Wrap empty container in newspaper and dispose in household garbage.
