DIRECTIONS: Buckle Hagen Flea collar around dog's neck securely but not too tightly. Allow a spacing of two fingers between collar and neck. Cut off and dispose of any excess length. Fleas on the dog will be killed and new ones which may temporarily appear on the dog will also be killed. American Dog Ticks and Brown Ticks are killed by this collar more slowly than fleas but will usually be dead in 1 to 5 days. Dead ticks occasionally remaining in dog's coat are easily detached. For best results, remove hard to kill ticks inside ears when collar is put on. When bathing dog, remove collar until dog is dry. Use the HAGEN Flea Collar in addition to regular collar. Replace collar when effectiveness diminishes.

PRECAUTIONS: Do not open inner envelope until ready to use. Do not allow children to play with this collar. Collar contains a cholinesterase inhibitor and is intended for use only as an insecticide generator. It is not to be taken internally by man or animals. Do not use on cats. For fleas on cats use Hagen Flea Collars for Cats. Do not use on animals under 8 weeks of age. Do not use on sick animals or on animals under drug or pesticide treatment. Before using on pregnant animals, consult a veterinarian. Remove collar if adverse reaction is noticed.

DISPOSAL: Dispose of expired collar, packaging and any excess collar with garbage to keep out of the reach of children.
