DIRECTIONS FOR USE:

GREENLEAF 1% ROTENONE DUST controls sucking and chewing insects; such as aphids, crickets, cabbage worms, cutworms, earwigs, flea beetles, leaf beetles, caterpillars, ants and other insects.

VEGETABLES:

Dust vegetables, flowers, ornamentals, or fruits any time that insects appear. Be sure to cover foliage well. Repeat as necessary. 60 grams will cover approximately 10 m² or 12 m of a 40 cm row. Do not use on vegetables within 1 day of harvest.

PETS (Cats, Dogs):

To control Fleas apply 1% Rotenone lightly to an area on the pet's back the size of your hand, and rub down to the skin. If fleas are abundant, apply lightly all over and rub down to the skin. For added control of fleas and lice, dust the animal's bedding and sleeping quarters. Apply lightly to cats since over-application may adversely affect them. For fleas around premises, lightly dust the infested area. Repeat as necessary.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN and away from hogs. Avoid contamination of feed and food. Wash after using. Do not inhale. Poisonous to fish and hogs.

FIRST AID: IF SWALLOWED, induce vomiting by inserting finger and touching back of the throat. Contact a doctor or call a Poison Control Centre. IF IN EYES, flush with water for 15 minutes and get medical attention. IF ON SKIN, wash with soap and water.

STORAGE: Keep product in original container. Store in a cool, dry place away from food.

DISPOSAL: Do not re-use empty container. Wrap container and discard in household garbage.
