NOTICE TO USER:

This control product is to be used only in accordance with the directions on this label. It is an offence under the Pest Control Products Act to use a control product under unsafe conditions.

DIRECTIONS:

FLIES, MOSQUITOES, GNATS, WASPS, FLYING ADULT MOTHS: Close doors and windows. Spray from 4 to 14 seconds per 100 cubic meters. Disperse in all directions. If possible, have fans operating to speed up circulation of aerosol fog throughout area being treated. Keep area closed for 15 minutes after treatment.

WEEVILS, FLOUR BEETLES, CHOCOLATE MOTHS, CARPET BEETLES, DRUG STORE BEETLES IN EXPOSED AND LARVAL STAGES: Contact as many insects as possible when treating infested areas such as cracks, crevices, stored products, machinery, dark secluded areas. Spray 10 to 20 seconds per 100 square meters of floor space. Repeat treatment weekly or as insects appear.

PRECAUTIONS:

In food processing and food service establishments, apply only when the plant is not in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operations.

In homes or dwellings, remove or cover all foods and cooking utensils before spraying to protect them from spray and dead or falling insects.

In barns, remove all animals from barn-building before fogging. Do not spray on food or feed. Avoid inhaling spray mist. Wash hands after use. Ventilate areas for 30 minutes before animal re-entry.

IMPORTANT:
