ELM BARK BEETLE: Mist blower. Apply in early spring when trees are dormant. Apply 9 - 11 litres of 12% solution per tree. (5 L product in 6L of water). A second treatment may be made at the end of July using a 6% solution. (2.5 L product per 7.5 L of water).

FALL AND SPRING CANKERWORM, TENT CATERPILLAR: Mist blower. Use a 6% solution (2.5 L product per 7.5 litres of water or 25 litres in 75 litres of water). Thoroughly cover all parts of tree

MOSQUITOES: Apply with a fogger. Make up a 6% solution. (50

litres Methoxychlor 25% in 155 litres of Diesel Fuel or 10 litres Methoxychlor in 30 litres of Diesel Fuel). Apply .7 - 1.4 litres of the mixture per hectare.
