SPACE SPRAY

ENVIROGUARD can be used with an automatic computerized U.L.V. fogging device or with a regular hand fogger. For rapid control of house flies, fruit flies, gnats, mosquitoes, indian meal moths, tobacco moths and other flying species in dairies, milk rooms, feed mills, institutions, food processing areas, food transportation vehicles. Close doors and windows and shut off ventilation system for 15 to 20 minutes. Apply as a fog or a fine mist, directing spray upwards to all parts of the room. Use 200-300 mL solution per 100 cubic metres per day. Repeat application if necessary. Vacate treated areas and ventilate before re-entry. The use of this product in food processing establishments should be confined to time periods when the plant is not in operation.

#### APPLICATION AREAS

For use in food processing plants, food service establishments, dairies, fish and meat packing plants, restaurants, hotels, and other areas with at least 1350 cubic metres of free air space where flies, mosquitoes and gnats are an annoyance. Set the system or hand fogger to release 75-300 mL of diluted spray per 1350 cubic metres of space per day. Remove animals from treated area and do not remain in the room. Close doors and windows and shut off ventilation system for 15 to 20 minutes. Ventilate thoroughly for 30 minutes before re-entry.

#### PRECAUTIONS:

##### KEEP OUT OF REACH OF CHILDREN

In food processing plants and food service establishments, apply only when the plant is not in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operation. For meat packing plants, treat only when plant is not in operation. No exposed meat products, ingredients or packaging materials to be kept in the room. Cover food handling equipment. All treated surfaces that may contact food products or other food products should be washed and rinsed thoroughly with potable water before re/use for food processing. Avoid contact with skin and inhalation of spray mist. Wash after using. Contents are toxic to fish and birds. Do not contaminate fish ponds.

#### DISPOSAL:

1. Rinse the empty container thoroughly and add the rinsings to the spray mixture in the tank.

2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product, and for clean-up of spills, contact the regional office of Environmental Protection, Environment Canada.

#### FIRST AID

If ingested, try to induce vomiting by giving one or two glasses of water and tickling the back of the throat by inserting a finger into mouth and touching the back of the throat. Contact a physician immediately. If in the eyes, rinse with water. If on skin, wash with soap and water. If irritation develops or persists, consult physician.
