DIRECTIONS: For the control of rats and mice: Place baits near living, and feeding areas and water supplies, such as around wall perimeters, in rat holes between walls or other protected areas.

FOR MICE: 10 - 15 g of bait should be placed at 3 to 4 meter intervals. An uninterrupted supply of bait should be maintained for at least 15 days.

FOR RATS: Each station should contain at least 120 g of bait, however, smaller bait placements of 30 - 60 g may be used when more placements are needed to efficiently feed the rat population present. Maintain constant supply of bait at stations for at least 10 days.

ONE DAY FEEDING WILL ACHIEVE CONTROL: when the baiting treatment utilizes a sufficient number of placements that have been consumed by the rats. Control will be evident, however, only in the following days.

PRECAUTIONS: PLACE BAITs IN TAMPER-PROOF BAIT BOXES OR PROTECTED AREAS INACCESSIBLE TO CHILDREN, PETS AND LIVESTOCK.
