DIRECTIONS: Before adding Simcoe-CC4, the pH should be tested and adjusted to within 7.2 - 7.6. Add muriatic acid if pH is high. Add soda ash if pH is low.

Simcoe-CC4 should be added daily to maintain 0.6 to 1.0 parts per million available chlorine. The use of a test kit is recommended, as the air temperature and the number of people in the pool will affect the amount of Simcoe-CC4 required.

Under average conditions, Simcoe-CC4 should be added daily to pool water according to the following chlorination guide.

| 20,000        | 250 - 500 mL    |

Note: First application should be double the high rate of the indicated amount.

Every three weeks, add one week's charge of Simcoe-CC4 in one application to ensure proper control of algae, slime and fungus. Avoid using pool until chlorine residual drops below 2.0 p.m.m. (approximately 24 hrs).

FOR SANITARY SWIMMING & WADING POOL WATER: Add the correct amount of Simcoe-CC4 to the water daily. For wading pools add 5 mL Simcoe-CC4 for every 100 L of water daily. Simcoe-CC4 is recommended for use in all types of pools; vinyl lined, concrete and fibre glass.
