DIRECTIONS FOR USE

Apply the following rates of Chipman Premium Lawn Weedkiller in at least 225 L per ha. Apply with an efficient boom sprayer, a pressure sprayer using the coarse spray, or watering can with a fine rosette spray. Spray to give thorough coverage of weeds without excessive run-off.

DANDELION, PLANTAIN, CURLED DOCK and HEAL-ALL - 4.5 L per ha (45 mL per 10 L of water per 100 m2).

CHICKWEED, KNOTWEED, CLOVER, BLACK MEDIC, CREEPING CHARLIE and BUTTERCUP - 7 L per ha (70 mL per 10 L of water per 100 m2).

APPLY IN SPRING OR EARLY FALL - REPEAT AS NECESSARY. Avoid spraying during hot, dry spells. Do not spray when rain is forecast. Delay application several days after mowing. After application, do not water for 24 hours and avoid mowing for at least 3 days. Killing action starts within 7 days, but takes more than a month. Best results when weed growth is active and temperatures are above 10'C.
