A premium grade ready to use insecticide solution for use in thermal foggers for the outdoor control of mosquitoes, blackflies, gnats, and other small flying insects.

DIRECTIONS:

For most effective treatment apply a dense fog close to the ground in insect breeding and resting areas at the rate of 11 L/ha or 100 mL/100 square m. Fogging should be done in early morning or late evening when the air is calm. When using a thermal fog generator, the equipment must be operated and maintained in the manner prescribed in the instructions affixed to it and by the manufacturer's manual. Repeat treatment during the season as often as necessary to control adult biting insects.

PRECAUTIONS:

Avoid inhaling spray mist. Avoid contact with skin, eyes and clothing. Avoid contamination of feed and food. Do not contaminate mangers, drinking troughs or utensils. Wash after handling or using. Avoid contamination of ponds, lakes, streams and other bodies of water which contain fish life or which may be used for irrigation or domestic purposes. Care should be taken in disposing of empty containers. Keep out of reach of children. Do not fog food crops. Keep away from fire or other sources of heat. Do not fog into open flame.

FIRST AID:

For external contact, wash with soap and water. If in eyes, flush with plenty of water. DANGER: This product contains petroleum distillates. Do not ingest. If ingested do not induce vomiting. If patient is unconscious give him air. Obtain medical attention immediately.

TOXICOLOGY:

Dichlorvos may cause cholinesterase inhibition. Atropine is antidotal.
