### DIRECTION FOR USE:

### SHAKE WELL BEFORE USING.

For effective flea control, adjust the spray nozzle to create a fine mist and apply uniformly without wetting furniture and carpeting. This product is designed for use on all fabrics and carpeting, however, some natural fibres (such as wool) and synthetics may be adversely affected by any liquid product always test a hidden area prior to use. One 1.9 L bottle will treat approximately 75 square metres (800 ft.2). Do not use as a space spray. Care should be used when treating wood surfaces, as water spotting may occur.
