DIRECTIONS:

SHAKE WELL BEFORE USING

1. Wet animal thoroughly.
2. Apply Starbar Equine Shampoo, working lather thoroughly down

to the skin from head to tail. Allow lather to remain 5-10 minutes.

3. Rinse and dry.

AN ALTERNATE METHOD MAY ALSO BE USED:
