DIRECTIONS FOR USE

All rates of applications are on the basis of dilute spray mixture. Dichlone 50-WP may be used in low volume or concentrate sprays by increasing the dosage to apply the same quantity of Dichlone 50-WP per hectare as would normally be applied when spraying dilute mixtures. Apply in sufficient water for thorough coverage of all plant parts; this volume depends on spray equipment and size of plants. Do not use in hot weather when temperatures are over 29°C. Do not apply to any fruit trees within 10 to 14 days following Bordeaux or oil.

CROP/DISEASE	METHOD/RATE
APPLE Apple Scab Cedar Apple Rust	PROTECTION PROGRAM: Apply DICHLONE at 0.25 kg per 100 L in a regular 5-7 day schedule to protect against scab. Start spraying at the green-tip stage and continue up to and including the Calyx spray. DO NOT MIX WITH OIL. DO NOT APPLY SOONER THAN 14 DAYS AFTER AN APPLICATION OF OIL.

APPLE Apple Scab Cedar Apple Rust	ERADICATION OF SCAB INFECTION: Apply 0.5 kg per 1000 L within 48 hours after the beginning of rain (at temperatures between 10 and 15°C).
DO NOT USE DICHLONE FOR 5 DAYS AFTER EVIDENCE OF FROST INJURY TO YOUNG FRUIT AS RUSSETTING MAY THEN OCCUR.	
PEACH, PLUM, CHERRY Brown Rot	To control blossom blight stage of Brown Rot, apply just before blossoms open and repeat throughout the bloom period at 4-5 day intervals if the weather is wet. On peach, plum and sweet cherry use 0.5 kg per 1000 L and on sour cherry use 0.25 kg per 1000 L.

#### COMPATIBILITY

This product is compatible with most commonly used insecticides and fungicides. Do not mix with oils, DNOC (Elgetol), parathion, Bordeaux and hydrated lime. If Dichlone is applied together with other insecticides, use wettable powders only and not emulsifiable concentrates.

**PRECAUTION:** KEEP OUT OF REACH OF CHILDREN.

Hazardous if swallowed, inhaled or absorbed through the skin. After handling, wash thoroughly with soap and water before eating, drinking or smoking and change to clean clothing. Do not apply or allow to drift to areas occupied by unprotected persons and animals or to streams, lakes or ponds to protect wildlife. Avoid contamination of feed or food, including such crops on which residue is unsafe. Dichlone is a skin irritant especially under high temperature conditions. Irritation caused by Dichlone is similar in nature to that of sunburn. There is no evidence of after effects or permanent injury. Avoid contact with powder. Wash hands and face thoroughly with soap and water after spraying or immediately upon sensing any irritation and use glycerol or silicone base skin cream (not lanolin, vaseline or oil-based creams).

**FIRST AID:** If swallowed, induce vomiting by touching the back of the tongue near the throat with a finger or blunt object; repeat until the vomit fluid is clear. Rush patient to nearest hospital taking this labelled container with you. In case of skin contact, remove contaminated clothing and wash skin with soap and water. If in eyes, flush with plenty of water 15 minutes and go to nearest hospital at once.

**DISPOSAL:** Dispose of spilled material and any containers which are contaminated by burying at least 45 cm deep, away from any water supply. Store product in a cool, dry place - do not freeze.
