Kills on contact and provides residual control. Use in homes, apartments, cottages, basements, garages, and household areas.

DIRECTIONS: Point valve opening towards surface to be sprayed and press button. Hold container about 30 cm from surface being sprayed and spray until wet. Keep children and pets away from treated surfaces until dry. **FOR CRAWLING INSECTS** such as ants, cockroaches, earwigs, fleas, spiders, centipedes, bedbugs, silverfish and crickets. For spot treatment: spray outside and inside house wherever crawling insects may enter or hide, such as door sills, baseboards, window frames, cracks and crevices in floors and walls, surfaces around pipes, behind and beneath cabinets, refrigerators, sinks, stoves, etc. Do not use in food storage areas or on surfaces that may contact food. Spray ant trails and hills. Repeat as necessary. For carpet beetles; treat underside of carpets, floors, baseboards, cracks, crevices, closets, and infested areas of shelving. Repeat treatment as necessary. **DO NOT USE ON RUBBER-BACKED CARPETS.**

FOR FLIES, MOSQUITOES AND OTHER FLYING INSECTS: Spot treatment: for use outdoors only. Spray outside surface of screens, doors, window frames. Also treat surfaces around light fixtures and other spots where these insects alight or congregate.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Wash hands after use. Do not use as a space spray. In case of contact with the skin, wash with soap and water. Do not use on humans, pets or foodstuffs. Do not contaminate food, utensils, food preparation surfaces, or fish bowls. Care should be taken in disposing of empty containers. Do not inhale spray mist. Spray harmful or fatal if inhaled. **CONTENTS UNDER PRESSURE.** Do not place container in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Keep away from open flame or spark. Dispose of empty container in garbage.
