DIRECTIONS FOR USE: SHAKE WELL BEFORE USING. Use only in upright  
position. Sprayer is tamper-resistant for the safety of the  
user. Depress button on nozzle and rotate nozzle counter  
clockwise until desired spray patten is achieved. Stand close to

the weed. No need to bend down. Wet the weed with one or two short bursts. Repeat as necessary. Fertilize and water the lawn to fill in bare spots after the weeds are killed. Knotweed and Ground Ivy may require repeated applications.

NOTE: Excessive wetting of grasses around weed may cause some injury.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed. Wash hands after use. Avoid contact with eyes, skin or clothing. Do not allow spray mist or vapours to contact any plants other than those being treated. Do not use on bent grass. Do not store near feed, fertilizer, seed, pesticides or food. Do not contaminate water supplies or bodies of water. DO NOT re-use the empty container. Dispose of empty container in garbage. Store above 0°C.

Protective Clothing: Wear long-sleeved shirt, long pants, socks and shoes.

Operator Use Precautions: Wash hands before eating, drinking, using tobacco or using the toilet. If pesticide penetrates clothing, remove immediately; then wash contaminated skin thoroughly and shower. Launder contaminated clothing separately before reuse.

Re-entry Interval: Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treated areas until spray has thoroughly dried.

#### FIRST AID

If in eyes, flush with water for 15 minutes. Get medical attention if irritation develops.

If on skin, wash with soap and water.

If swallowed, obtain medical treatment or contact a Poison Control Centre.
