NOTICE TO USER: This control product is to be used only in accordance with the directions on this label. It is an offense under the Pest Control Products Act to use a control product under unsafe conditions.

NATURE OF RESTRICTION: For sale only to pest control operators, farmers and persons authorized in government- approved pest control programs where the vendor maintains a record of sales including the name, address and signature of the purchaser along with the quantity of product purchased.

RESTRICTED USED: For control of Richardson's ground squirrels (*Spermophilur richardonii*).

DIRECTIONS: STIR thoroughly before using. Keep from freezing. Pour the contents of this can over 4 litres of clean oats or wheat. Where oats is sown use wheat for bait; where wheat is sown use oats for bait. Stir thoroughly until each kernel is coated with the poison. It dries quickly and is ready for use at once. Place 5 mL of the poisoned grain in the burrow of the

gopher. DO NOT SCATTER BAIT OUTSIDE BURROW, TO PROTECT WILDLIFE. The treated grain can be stored and keeps its killing effect. It is not affected by heat or cold.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. CONTENTS MAY BE UNDER PRESSURE. Very dangerous if swallowed. Wear a protective mask for your mouth and rubber gloves when preparing bait. Even so, wash hands immediately after using and before eating or smoking. Do not contaminate food, feed or any water supply. Mark containers with bait "POISON - STRYCHNINE BAIT". Bury dead pests; do not leave where carnivores might have access to them. Toxic to all forms of life.

FIRST AID: Obtain medical attention immediately. If swallowed, induce vomiting immediately before the onset of reflex hyperexcitability (convulsions). It is a safer procedure to ingest a slurry of 30-45 g of activated charcoal in a glassful of water. Gastric lavage is postponed until the patient is fully premedicated. Keep patient in a dark, quiet, warm room with minimal sensory stimulation. Ingest intravenously sufficient amounts of barbiturate drugs to prevent further convulsions (amobarbital sodium or pentobarbital sodium). Artificial respiration may become necessary. Keep patient under continual observation until convulsions and reflex irritability have been suppressed and gastric lavage can be performed safely.

TOXICOLOGY: The treatment should consist of gastric lavages following which activated charcoal should be left in the stomach. If symptoms of convulsions or spasm have begun avoid any manipulations including lavage. Control the seizures with diazepam or amytal intravenous Succinylcholine may be used with artificial respiration if other methods fail.

DISPOSE of empty can by burying at least 50 cm deep, away from any water supply.
