**DIRECTIONS:** SHAKE WELL BEFORE USING. A product for use outdoors. Kills flies, mosquitoes, black flies, gnats, moths, hornets, wasps. Spray only when air is still and temperature is under 32°C. Point special fogging nozzle away from you in a slightly downward direction. Fog area where insects are a nuisance and the surrounding bushes or grass. Fog will extend up to six metres from nozzle. Stand at least 2 metres from target. Spray beyond the immediate area where control is desired to achieve longer control. Repeat as necessary. This product only kills insects contacted by fog.

**PRECAUTIONS:** KEEP OUT OF THE REACH OF CHILDREN. Do not puncture or incinerate. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Avoid contact with skin, eyes and clothing. Avoid inhalation of spray.

Wash hands after using. Keep from freezing. Avoid contact with Maiden Hair Ferns. Do not contaminate any body of water.

**FIRST AID:** Avoid inhalation or exposure of eyes to fog. In case of eye contact, flush with clean water for 15 minutes. If irritation persists, call a physician or poison control centre at once. If accidentally swallowed, call a physician or poison control centre at once. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
