insecticidal sprays, both liquid and pressurized. This product give a 1:2:3.3 proportion of d-trans allethrin:piperonyl butoxide:MGK 264. For example, this intermediate might be used at the rate of 0.556% (wt.) with 0.5% to 1.0% o- Isopropoxyphenyl methylcarbamate, or 0.5% 0,0-Diethyl o-(2- isopropyl-6-methyl-4-pyrimidinyl) phosphorothicate, with approved solvents and propellents in the preparation of pressurized roach and ant sprays. Or, it could be used at the rate of 1.12% (wt.) in good refined base oil to product a space spray for small flying insects.
