It both cleans and disinfects effectively and is virucidal when used as directed. Its hard surface disinfecting action will reduce the hazard of cross-contamination from environmental surfaces.

When used as directed, DIMENSION IV will deodorize toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas, and will inhibit the growth of mild and mildew and their odors.

This product is economical to use because it is highly concentrated and should be handled with care.

CONTAINER DISPOSAL

1. Rinse the emptied container thoroughly and add the rinsings to treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
3. Dispose of the container in accordance with provincial requirements.
4. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environment Canada.

FIRST AID

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are no available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

DIRECTIONS FOR USE

DIMENSION IV is a proven "one-step" cleaner-disinfectant-sanitizer-fungicide-virucide in the presence of moderate amounts of organic soil.

Apply DIMENSION IV to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks and bedframes with a cloth or mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

DISINFECTION - to disinfect hard, non-porous surfaces, add 4 mL/L (0.64 fl. oz/gal.) of water. Treated surfaces must remain wet for 10 minutes. At this use-level, DIMENSION IV is also virucidal and fungicidal.

SANITIZING - to sanitize porous or non-porous, non-food contact surfaces, add 1.5 mL/L (0.24 fl. oz/gal.) of water. 4 mL/L (0.64 fl. oz/gal.) use-level. This broad spectrum activity of DIMENSION IV has been evaluated in the presence of 5% serum and found to be effective against the following by the AOAC Use-Dilution Test:

AOAC Fungicidal Test

DIMENSION IV is effective against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, shower and bath areas, exercise areas, dressing rooms, etc.

Mildewstatic Performance. At 4 mL/L (0.64 fl. oz/gal.) DIMENSION IV will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.

Virucidal Performance. At 4 mL/L (0.64 fl. oz/gal.) DIMENSION IV was evaluated in the presence of 10% serum and found to be effective against the following viruses - Herpes Simplex (a member of the virus family that causes infectious mononucleosis). Vaccine (representative of the pox viruses), and influenza A2 (the Hong Kong flu virus) on inanimate environmental surfaces.

SANITIZING-NON-FOOD CONTACT SURFACES (such as floors, walls, tables, etc.) At 1.5 mL/L (0.24 fl. oz/gal.) use level, 30 second contact time DIMENSION IV is an effective sanitizing agent in waters of up to 600 ppm hardness against Staphylococcus aureus and Klebsiella pneumonise in the presence of 5% serum on porous and non-porous environmental surfaces.
