**DIRECTIONS FOR USE:**

THE AGRITAC SUPERIOR OIL 70 is an emulsible insecticide mineral oil used for control of insect and mite pests on apples, pears, peaches, plum and cherries. Follow Provincial recommendations for proper timing of sprays.

**N.B. DO NOT USE** AGRITAC SUPERIOR OIL 70 on Red Delicious or Empire apples. Little or no injury occurs on most other varieties of apples trees. Do not spray during or prior to freezing, i.e... temperatures below 0'C. Thorough coverage is essential for effective control of pests, but avoid over-spraying.

**MIXING INSTRUCTIONS:**

Fill the spray-tank half-full with water. With agitator running, add the required amount of the active chemical. Continue agitation and till the spray-tank until it is almost full. Finally, add AGRITAC SUPERIOR OIL 70 to the tank. The mixture should turn while indicating good emulsion. Do not use spray mixture if the product is not emulsified. For further information regarding mixing and application of insecticide oils, consult local agricultural authorities.

**PRECAUTIONS: KEEP OUT OF REACH FROM CHILDREN**

Keep away from fire, open flame, heat sources or sparks. Do not breathe oil mists. Do not contaminate foods for animals or humans. Avoid contact with skin, eyes, or clothing. Do not

contaminate water supplies, irrigation ditches, ponds, lakes or streams.
