USE DIRECTIONS

CADISAN-1.6 is a cleaner-disinfectant-sanitizer-deodorizer-
fungicide-virucide especially formulated for use in food
processing plants, restaurants, dairies and other places where
food is handled or prepared. It contains no perfume or dye.
When used according to directions it is effective against
Staphylococcus aureus - Salmonella choleraesuis - Pseudomonas
aeruginosa - Salmonella typhosa - Escherichia coli -
Brevibacterium ammonia-genes - Klebsiella pneumoniae and

Influenza A2 Vaccinia viruses and pathogenic fungi such as Trichophyton interdigitale.

RECOMMENDED FOR USE on environmental surfaces such as floors, walls, tables, chairs, counters, sink tops, garbage pails, all food equipments, rest rooms, etc. Very effective for killing odour producing bacteria, molds, mildew and fungi.

HEAVY CLEANSING AND DISINFECTION: Use 1 part to 25 parts of water. Apply with a cloth or mop. Rinse surfaces subject to direct contact with food thoroughly with potable water before re-use. DO NOT MIX WITH OTHER CLEANERS. Rinse empty container with water before discarding.
