## DIRECTIONS FOR USE:

HORSES: For the control of Lice, Fleas, Horn Flies and Winter Ticks, dust the entire animal thoroughly using not more than 500 grams of dust per head. Repeat if necessary, but not more than twice weekly. For Louse control, repeat at intervals of 14

to 18 days.

CAUTION: Do not exceed dosage given above.
