It also controls sucking insects such as Whiteflies, Mites, Thrips, Aphids and Scales which feed on leaves and stems. C-I-L Fungus Gnat Killer controls Spiders which do not harm house plants but are often a nuisance.

DIRECTIONS: If possible, move plants outside for treatment. For soil insects, apply dust lightly to soil around plant. For foliar plants, thoroughly cover leaf surfaces. Repeat as needed but no more than once every 2 months. NOTE: DO NOT USE ON ROSES, AZALEAS, CAMELLIAS, POINSETTIAS, GERANIUMS, OXALIS, COLEUS OR VARIEGATED IVY.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid inhaling dust. May cause irritation to the respiratory tract, skin or eyes; avoid contact. Do not allow dust to contact food, food preparing surfaces, utensils or drinking water. Wash contaminated food surfaces and utensils with soap and water. May cause irritation to skin or eyes; avoid contact. Wash thoroughly with soap and water after using. This product is toxic to fish. Avoid contamination of ornamental fish ponds and fish bowls. Keep children and pets away from dusted plants

until watered and dry.

FIRST AID: If swallowed, DO NOT induce vomiting. Seek medical attention or call a poison control centre immediately. If in eyes, flush with water and get medical attention. If on skin, wash thoroughly with soap and water. If inhaled, remove from site of exposure.

TOXICOLOGICAL INFORMATION: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection only is an antidote.

DISPOSAL: Do not reuse empty container. Dispose of the empty container with household garbage.
