In recirculating cooling tower systems and pulp and paper mill process water, use at rate of 20-100g/10,000 (Kl) of water contained in the system.

Begin treatment when the system is in jeopardy of becoming affected or after cleaning systems whose efficiency is already impaired. Apply at a point in the system where the product will be uniformly mixed. Repeat treatment every day, or as needed. In the event the system is badly fouled, precleaning is recommended.

Measurement of the residual chlorine levels in the systems should be made on a periodic basis to insure a 0.2 to 0.5 part per million (ppm) residual minimum.
