DIRECTIONS:

Remove child resistant cap with a coin or tool. Shake to apply. Re-apply cap after use. To open, punch in holes marked on lid.

LAWNS: Make no more than 2 applications per season. White grubs, European chafer larvae, Japanese beetle larvae - Apply 400 g per 10 m² and water into turf. Ants - Apply 200 g per 10 m². Treat ant nests and trails. Chinch bugs - Apply at a rate of 200 g per 10 m² at first sign of damage. Water thoroughly. Keep off lawn until dry.

GARDENS: Use on broccoli, Brussels sprouts, cabbage, Chinese cabbage, cauliflower, carrots, celery, cucumbers, green

peppers, onions, potatoes, sweet corn and tomatoes. Do not use on green bunching onions. For control of cutworms and root maggots, apply dust to soil around plant at a rate of 70 g per 10 m of row if damage is expected. Chemical control of white grubs and wireworms is usually needed only the year after sod has been turned.

DAYS TO WAIT BETWEEN APPLICATION AND HARVEST:

ORNAMENTALS: Make no more than 2 applications per season. For ants, crickets, earwigs, sowbugs, spiders, cutworms, white grubs, European chafer larvae and Japanese beetle larvae, apply dust to turf or to soil around plants at a rate of 400 g per 10 m².

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN.

Do not allow dust to contact food, food preparing surfaces, utensils or drinking water. Wash contaminated food surfaces and utensils with soap and water. Do not use in poultry houses or other animal buildings. May cause irritation to skin or eyes, avoid contact. Avoid inhaling dust. Wash thoroughly with soap and water after using.

WARNING: This product is toxic to fish and crustaceans. Avoid contamination of ornamental fish ponds and fish bowls. Dispose of the container away from food, feed and water supplies.

FIRST AID: If swallowed, induce vomiting and contact a physician or poison control centre. Flush contaminated eyes and skin with plenty of water. For eyes, get prompt medical attention.

TOXICOLOGICAL INFORMATION: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection only is an antidote. DISPOSAL: Do not reuse container. Wrap and dispose of in household garbage.
