DIRECTIONS:

Shake well before using. Hold can in upright position 25-30 cm from pet and spray entire body beginning at tail and working towards the head. Do not spray face, eyes or genitals. As you spray, fluff the hair so that spray will penetrate to the skin, but spray only until hair is damp - not wet. Spray Ticks directly. Repeat as necessary. Do not use on puppies or kittens under 8 weeks of age or nursing females. Do not spray more than once a week. Consult veterinarian before use on pregnant animals. Do not use on sick animals or animals under drug or other pesticide treatment.

For effective flea and tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required. Spray infested areas such as pet's bed and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Remove old bedding and replace with fresh clean bedding after treatment.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not puncture or incinerate container. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over 50'C. Do not spray near open flame or spark or while smoking. Do not spray in eyes, or face, or on genitals of pet. Discontinue use if dermal or nasal irritation develops. Do not use near birds, fish, food or foodstuffs. Avoid inhalation of spray. Avoid skin contact by wearing rubber gloves. Wash hands after use.

DISPOSAL: When container is empty press valve to release pressure. Dispose of empty container in regular household garbage.

FIRST AID:

If on skin, wash thoroughly with soap and water. If sprayed in eyes, flush with clean water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical

attention at once.
